Misuse of funds, for JRY in Different States

Governments in 1995-96 have not been properly spent;

(b) if so, the reasons for the under utilisation and misutilisation of funds under JRY in different States;

(c) the State-wise reports in this regard as on 31st October, 1995; and

(d) the steps taken to plug the loopholes?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL AREAS AND EMPLOYMENT (DEPARTMENT OF RURAL EMPLOYMENT AND POVERTY ALLEVIATION) (SHRI VILAS MUTTEMWAR): (a) to (b) The rate of utilization of funds under JRY for all the States and UTs. together in the country was about 52% of the total available resources as on 31 October, 1995. A statement showing the State-wise utilisation of funds under the Scheme is given below. It may be stated that the rate of utilisation of funds during the first half of the year is generally low on account of the monsoons in most parts of the country. It has been observed, that the rate of utilisation picks up further during the second half of the year.

In order to ensure proper utilisation of funds, the implementing agencies are required to submit Utilisation certificates and an Audited Statement of accounts to the centre. JRY. funds of the DRDA and the Panchayat levels are required to be maintained in a separate account. Further, the second instalment of funds to the States is released to the implementing agencies only when they have utilized 50% or more of the available funds with them i.e. opening balance of the year and the amount received during the year.

Apart from the above measures which are inter-alia built into guidelines, the Centre has recently written to the State Governments requesting them to constitute State/District and Block level Vigilance Committees for monitoring the use of funds and the implementation of the Scheme at the respective levels.
