

Financial Assistance is being provided in a phased manner at the rate of Rs.50.00 lakhs per district per year for improving infrastructure in these backward districts.

However, there is no scheme under which primary health care facilities are to be upgraded through World Bank assistance.

(a) whether it is a fact that patients visiting OPD of Dr. Ram Manohar Lohia Hospital, New Delhi are not getting medicines and injections;

(b) whether it is also a fact that the Hospital authorities are not paying any attention towards the patient care facilities;

(c) if so, whether Government propose to conduct surprise checks in the Hospital to ascertain the actual position from the patients;

(d) if so, when and if not, the reasons therefor; and

(e) the other steps Government propose to take in this regard

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI A.R. ANTULAY): (a) and (b) No such report has been received in the Ministry.

(c) to (e). The Directorate General of Health Services monitor the services of the hospital periodically and take appropriate action for upgradation of facilities within the overall availability of resources.
