Newspaper Report on MOP Import

1196. SHRI RAMDAS AGARWAL: Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

- (a) whether Government's attention has been drawn to news-item captioned "PMC halts Yadav move on MOP import" from Germany instead of Russia as published in the Financial Express, dated 17th November, 1995;
- (b) whether there is any controversy between the Department of Chemicals and Fertilizers and Ministry of Agricuture over this deal; and
- (c) the steps Government have taken so far to ensure that no adverse impact on the farm gate price of this important nutrient Muriate of Potash (MOP) for the Indian farmers takes place apart from temporary shortage and rise in prices etc. prevailing in the country?

THE MINISTER OF CHEMICALS FERTILIZERS (SHRI RAM AND YADAV): LAKHAN SINGH Imports of Muriate of Potash (MOP), a decontrolled fertiliser. have been decanalised w.e.f. 1993. 17th June. There is no decision by Government to stop imports of MOP from any source including Russia.

- (b) No. Sir.
- (c) No shortages have been reported of MOP availability in the country during 1995-96. After decontrol and consequent withdrawal of subsidy, the sale price of MOP has gone up. Govt. has been helping the farmers by giving an ad-hoc concession of Rs. 1000/-PMT since 1.10.1992.

- (b) As per the information received from the Board, the seminar highlighted the component of Value Education in existing curriculum for promoting Value Education and covered topics like, practices followed for promoting Value Education in different schools, methodologies for promoting value Education, cultural contents of Value Education and orientation of teachers.
- (c) The Board plans to evolve guidance for use in sehools based on the recommendations of the seminar.
