- (a) whether India used the opportunity provided by the 4th International Conference at Beijing held in September, 1995, to have issuer like the compensation for women for their unpaid toil of love for the family at large, settled and resolved; and
- (b) if so, what specific issues were raised and taken up by Indian representative at the Beijing Conference and what consensus and decisions were arrived at in regard thereto?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF WOMEN - AND CHILD DEVELOPMENT) (KUMARI VIMLA VERMA): (a) and (b) The Indian delegation took the opportunity of the Wqrld Conference at Beijing and, participated actively in the deliberations and also in drafting of the Platform For Action (PFA) through various Committees, Working Groups and Sub-Groups. It provided necessary inputs

relating to unremunerated work of women in the P.F.A. which is the consensus document adopted at the Fourth world Conference on Women with a commitment from Member— Countries for follow-up action. The relevant references as appeared in the P.F.A. arc given in the enclosed statement.

#### Statement

Access to Economic Structures

- (i) To develop a more comprehensive knowledge of work and employment through, inter-alia, efforts to measure and better understand the type, extend and distribution of unremunerated work.
- (ii) Improve data collection on the unremunerated work and develop methods for assessing quantitative value of unremunerated work that is outside national accounts.
- (iii) To improve methods to accurately reflect its value in satellite accounts that are separate from but consistent with core national accounts.
- (iv) develop on interational classification of activities for time-use statistics that is sensitive to the differences between women and men in remunerated and unremunerated work and collect data disaggregated by sex.

## Preservation of paintings of Churches in Old Goa

- (a) whether Government are aware of the fact that ancient wall paintings on the Churches at Old Goa, are systematically being destroyed due to their non-maintenance by ASI, which forms part of antiquity -and International Heritage;

- (c) whether any foreign help has been offered to repair and maintain them;
  - (d) if so, the details thereof; and
  - (e) Governments response thereto?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT EDUCATION AND DEPTT. OF CULTURE) (KUMARI SELJA): (a) The ancient patintings on the walls of the centrally protected Churches, in Old Goa, are being properly maintained & preserved by the ASI. However, due to high humidity in the area some mural paintings, due to their inherent characteristics, are adversely affected by the climate.

- (b) The ASI has not defaced/ destroyed any painting by applying paint over it. On the Contrary some paintings that were covered by lime wash have been scientifically exposed & preserved.
