EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) The totar Revenue Expenditure on education by Education Departments \*bf Centre and States in 1993-94(RE) is about 3.5 percent ok GNP.

(b) While there is no international norm, India's expenditure on education as percentage of GNP compares favourably with other developing countries.

(c) Social sector spending has not decreased. Total Central Plan outlay for major schemes of Social Sectors has increased by 45.54 percent from Rs. 9387 crores in 1993-94(BE) to Rs. 13662 crores in 1995-96(BE) as against the price rise of 28.5 percent during the same period.

(d) Faster economic Growth coupled with restructuring of Central and State budgets would enable achieving the goal of raising public outlay on education to six percent of GNP.

## Memorandums submitted by Dalit Christian Association

1219. SHRI V. GOPALSAMY: Will the Minister of WELFARE be pleased to state:

THE MINISTER OF WELFARE (SHRI SITARAM KESRI): (a) and (b) A large number of representations from Dalit Christian Associations/ Organisations demanding Scheduled Caste status-and extension of reservation benefit as SCs have been received.

(c) The matte/ relating to extension of Scheduled Caste status to the Christians of Scheduled Caste origin is under consideration of the Government. In so far as the reservation in services is concerned, the Scheduled Caste converts to Christianity are eligible as OBC in the States of Andhra Pradesh, Assam, Bihar, Gujarat, Karnataka, Kerala, Madhya Pradesh, Maharashtra, Punjab, Tamil Nadu and UTs of Pondicherry and Daman & Diu. Reservation benefit in the services of Central Government and its Public Sector Undertakings is available to this community w.e.f. 8th September, 1993 under OBC category.

KRUPASINDHU BHOI): (a) to (c) The Executive Committee of the National Council of Educational Research and Training (NCERT) in its meeting held on 19th July, 1995 desired that NCERT should update the curriculum and teaching/ learning material of the course in computer education every year in order to keep pace with the latest developments. The Council proposes to update textual/learning material in computer education on receiving feedback from the users.

# Loss of Production due to non-Supply of Natural Gas to Namrup Units of HFC

# 1222. SHRI DIPANKAR MUKHERJEE: SHRI NILOTPAL BASU:

Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

(a) the production loss suffered by Namrup unit during 1994-95 and in six months from April to September, 1995 due to inadequate supply of Natural Gas;

(b) whether OIL and ONGC are making fresh commitment to supply gas to other industrial units/companies while failing to augment the gas supply to HFC, Namrup; and

(c) the remedial action taken by the ministry to ensure requisite amount of gas to Namrup unit?

THE MINISTER OF CHEMICALS AND FERTILIZERS (SHRI RAM LAKHAN SINGH YADAV): (a) It has been estimated by HFC that there was a production loss of 4.7 lakh tonnes of urea in the Namrup units of HFC during 1994-95 and April-September, 1995 due to limitation in supply of natural gas.

(b) ONGC.and OIL are supplying gas only to units which have been allocated gas by the Government.

(c) The supply to HFCL is being increased in the short term by connecting up sources of low pressure gas. OIL is examining the proposals to develop its free gas reserves.
