THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI P. CHIDAMBARAM): (a) The authorised crop size of FCV tobacco fixed for Andhra Pradesh by Tobacco Board for 1995-96 season is 75.47 Kgs. It is too early to estimate the expected FCV tobacco production in Andhra Pradesh as planting is on progress.

(b) and (c) The impact of cyclone has been noticed on the FCV tobacco nurseries, transplanted crop and barns in East Godavari, West Godavari, Khammam, Warangal, Karimnagar, Krishna and Guntur districts of Andhra Pradesh. On account of cyclone, the total production of FCV tobacco in Andhra Pradesh is likely to decline by about 1%.
