

THE MINISTER OF STATE OF THE MINISTRY OF TEXTILES (SHRI KAMAL NATH): (a) There were two cotton/man-made fibre textile spinning mills in the State of Madhya Pradesh situated in the district of Khandwa and Kargone under co-operative sector as on 31.10.95.

(b) Demand of yarn for handloom and powerloom sectors is met out of the production of yarn by all the textile mills within the State and outside, and not by the cooperative spinning mills alone.

(c) and (d) As per the Liberalised Industrial Policy, notified on 25.7.91, there is no restriction on the setting up of cotton textile mills, except for certain textile locational restrictions, irrespective of whether the proposed mills are in the public, private or cooperative sector.

#### LPT Projects in Maharashtra

1454. SHRI SATISH PRADHAN: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) The number of LPT projects approved/completed so far in Maharashtra alongwith the proposals under execution for completion during the current year with names of places;

(b) details of the proposals sought to be approved under consideration and likely time for approval alongwith the target for the current year;

(c) what are the other, major projects currently under execution and progress reported thereon-project wise in Maharashtra;

(d) the details of important proposals from Maharashtra which are in pipeline at various stages of decision making process?

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI P.M. SAYEED): (a) to (d) The work on implementation of 8 (eight) Low Power Transmitter (LPT) projects have been completed, till date, in the current financial year in Maharashtra. The locations of such transmitters are given in statement-I (*see below*). Out of these, 5 LPTs viz. Meheker, Chikli; Brahmपुरi, Nagpur DD-II and Arvi have since been commissioned into service. TV projects which are expected to be made ready during the remaining period of 1995-96 in the State, subject to availability of infrastructural facilities and timely supply of equipment, are given in statement-II (*see below*).

The details of various other TV projects, which are, at present, under implementation in the State of Maharashtra are given in statement-III (*see below*). These projects are at various stages of implementation and are expected to be completed, in phases, by 1997-98, subject to availability of requisite infrastructural facilities, timely supply of equipment and *inter se* priorities.

With a view to further strengthen/ augment TV service in Maharashtra, a number of TV projects are envisaged to be set up in the State depending on availability of adequate resources for the purpose and *inter-se* priorities. The requisite details are given in Statement-IV (*see below*).

**भून्तर हवाई पट्टी की सुरक्षा दीवार का क्षतिग्रस्त होना**

1455. श्री महेश्वर सिंह: क्या नागर विमानन और पर्यटन मंत्री यह बताने की कृपा करेंगे कि:

(क) क्या उन्हें इस बात की जानकारी है कि कुल्लू जिले में सितम्बर महीने में व्यास नदी में आई बाढ़ के कारण भून्तर हवाई पट्टी की सुरक्षा दीवार और बाढ़ नियंत्रण कार्य को क्षति पहुंची थी, जिसके परिणामस्वरूप हवाई पट्टी का अधिकांश हिस्सा मलबे के नीचे दब गया था;

(ख) क्या यह भी सच है कि इसके परिणामस्वरूप कई दिनों के लिए उड़ानें रद्द कर दी गई थी;
