- (b) and (c) In 24 cases relating to molestation and rape οf women registered by the CBI, field investigations have already been completed and evidence is being assessed for filing report under Section 173 Cr. P.C. in the competent Court. In cases pertaining to wrongful confinement and restraint, sanction sought by CBI to prosecute officials has been accorded recently by the State Government. In the eleven cases involing death, investigation in complete in nine cases and evidence is being assessed.
