(ख) से (घ) राष्ट्रीय राजधानी क्षेत्र दिल्ली (29.71 कि॰ मी॰) से गुजरने वाले रा॰रा॰ सं॰ 10 के रूप में ज्ञात दिल्ली-रोहतक-हिसार-सिरसा राजमार्ग खंड पर पहले ही 4 लेन हैं। बहादुर गढ़-रोहतक खंड (35 से71 कि॰ मी॰) को 8वीं पंचेवर्षीय योजना के दौरान चौडा करके 4 लेन बनाने का प्रस्ताव है और चाल वित्त वर्ष 1995-96 के दौरान 5.00 करोड़ रु॰ की अनुमानित लागत से भूमि अधिग्रहण करने के लिए योजनागत प्रावधान है। इस परियोजना के लिए भूमि अधिग्रहण के प्राक्कलन को अभी स्वीकृत किया जाना है।

Government's Reaction to the Former US Secretary's statement on Arms Sale to Pakistan

1674. SHRI G. **PRATHAPA** REDDY: SHRI T. VENKATRAM REDDY:

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether Government's attention has been drawn to the news item captioned "Pressler alleges arms sale to Pakistan" which appeared in Statesman dated the 10th July, 1995; and
- (b) if so, the details thereof and the reaction of the Government thereto?

THE MINISTER OF EXTERNAL **AFFAIRS** (SHRI **PRANAB** MUKHERJEE): (a) Yes, Sir.

(b) US Government arms supplies to Pakistan and taken place on a large scale after the introduction of the Pressler Amendment to the Foreign Assistance Act in 1985 on the basis of US Presidential certifications that Pakistan did not possess a nuclear explosive device. Government are not aware of sales by the US Government to Pakistan of military equipment since October 1990, when US Government military and economic assistance to Pakistan ceased under the provisions of the Pressler the Amendment. following President's inability to certify Pakistan did not possess a nuclear explosive device. Commercial sales, at a non-government level, however, do not fall within the purview of the Pressler Amendment.

Government remain committed to take al steps required to safeguard India's security.
