Instructions have also been issued for carrying out repairs in the building such as the lavatory block and steps taken for improving the hygcinic conditions of Homes and of die inmates. The Superintendents of the Beggar Homes have also been directed to maintain a Complaint Register in respect of complaints pertain ng to electricity, water, sewage etc. and to contact concerned officers of various departments to get the problems solved. Surprise visits and inspections an also done and necessary action/taken instructions given on the spot.

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF YOUTH AFFAIRS & SPORTS) (SHRI MUKUL WASN1K): (a) The Board of Governors of the Nehru Yuva Kendra Sanguthan in its meeting held on 1<S 08.1993 approved a revised structure for the management of the Sangathan abolishing the existing Zonal System and introducing State Offices in order to decentralise the powers.

- (b) No, Sir.
- (c) and (d) Yes, Sir. The Programme Evaluation Organisation (PEO) of Planning Commission conducted a study on Nehru Yuva Kendra Scheme in 1991 and in their report it has been mentioned that the results of the study icvealed that:

"The scheme has generated awareness among the rural youth about their environment, naitonal values and issues, development programmes and activities, in many cases, youth clubs have been associated which helped the village panchayats in creating assets in the villages in a cooperative and voluntary manner, building up organisational skills etc."
