  - (iii) Workshop on 'Economic Policies and Social Justice' organised by All India Trade Union Congress on 22—24 March, 1995.
  - (iv) A study was conducted by the Gandhi Labour Institute, Ahmedabad on Rehabilitation of Retrenched Workers under the 'National Renewal Fund'.

## Committee to Review Functioning of EOUs/EPzs

CHIDAMBARAM): (a) to (c) The Government had constituted a Committee to review the policy and procedures applicable to EOU/EPZ units on 19.1.1993, Report which submitted its 14.12.1993. The major recommendations contained in the Report include broadening the area of activity to include trading, re-export after repacking/labelling, repairs, reconditioning and re-engineering, inter-scheme mobility, facility to remove excess capital goods into domestic market through partial debonding, unification of basic norms of various export promotion schemes, duty reduction on DTA sale of finished products and waste/scrap per-
