## Clearance to Pooyamkutty Hydro Electric **Project**

2443. SHRI JOY NADUKKARA: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

- whether the clearance for Pooyamkutty Hydro Electric Project is pending before Central Government for clearance;
- (b) whether Government are aware that while the Hon'ble Prime Minister visited Kerala recently, he promised clearance for this project; and
- (c) whether Government would take steps to give clearance to this project immediately in view of the fact that Kerala is facing acute shortage in Electricity, if so by when?

THE MINISTER OF STATE OF THE MINISTER OF ENVIRONMENT AND FORESTS (SHRI RAJESH PILOT): (a) The Pooyamkutty Hydro Electric Project, Kerala was approved from Environmental angle in June, 1985 but the final decision on diversion of 3001.8. ha. of forest land under the Forest (Conservation) Act, 1980 has not yet been taken.

- (b) Speeches made by the Prime Minister during his recent visit to Kerala in November, 1995 indicated no such assurance.
  - (c) the matter is under examination.

## Telephone Facilities to Members of **Panchavats**

SHRI JOY NADUKKARA: the Minister Will of COMMUNICATION be pleased to state whether Government would take steps to include the Members of Gram Panchayats, Block Panchyats and District Panchayats in the special category for grant of telephones so that they may be preferred in getting phone connections which will help them in discharging their duties as public servants?

THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATION (SHRI SUKH RAM): Sir, there is no proposal to include Members of Gram Panchayats, Block Panchayats and District Panchayats for registration under Special category, for the present.
