

**Working Women's hostels hi
Madhya Pradesh**

2812. SHRI DILIP SINGH JUDEV: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether there is a plan for construction of a number of working women's hostels in Madhya Pradesh;

(b) if so, the details indicating the capacity and cost thereof;

(c) the time schedule of construction thereof; and

(d) whether any policy guidelines have been laid down by Central Government about the need and desirability of working women's hostels in different cities/towns; if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF WOMEN AND CHILD DEVELOPMENT) (KUMARI VIMLA VERMA): (a) to (d) State/ Union Territory-wise allocation of funds is not made under the Scheme of Assistance for Construction/Expansion of Hostel Building for Working Women with a Day Care Centre for Children. Projects are sanctioned on the basis of complete proposals received from eligible organisations through the State Governments. Since the inception of the Scheme in 1972-73, 65 Working Women's Hostels to accommodate 3307 working women have been sanctioned in Madhya Pradesh. At present, 5 proposals to provide accommodation to 269 working women have been received from organisations in Madhya Pradesh. They have been scrutinised and the applicant organisations have been advised to submit additional information and documents to meet the schematic requirements. Normally, projects are sanctioned with per capita cost not exceeding Rs. 40,000/-. Construction of hostel building is required to be completed within a period of 24 months

from the date of release of the first instalment of Grant-in-aid.

2. On the basis of the primary data about the employment of working women in organised sectors collected from the Employment Exchanges by the Directorate General of Employment & Training, Ministry of Labour, City/ town-wise broad assessment has been made about the number of working women in need of hostel facilities. City/ town-wise assessment of number of working women requiring hostel accommodation in Madhya Pradesh is given in the statement (*See below*). However, Projects are sanctioned on the specific recommendations of the State Governments.

Status of Ambedkar University

(a) the present status of Ambedkar
University in Uttar Pradesh;

(b) whether Government is
considering to upgrade its present status
to a Central University status;

(c) if so, the reasons for giving it a
higher status; and

(d) the benefits that will accrue by its
upgradation and how the financial part
will be taken care of?

(KUMARI SEUA): (a) to (d) Considering
the requests from several quarters,
including the Government of Uttar
Pradesh and also the recommendations of
the Standing Committee for the Centenary
Year of Babasaheb Bhimrao Ambedkar in
this regard, the Government decided in
1993 to convert the Dr. B.R. Ambedkar
University into a Central University by the
name of Babasaheb Bhimrao Ambedkar
University (BBAU).

Legislation to give effect to this
decision was enacted by the Parliament in
August, 1994. The date of
commencement of BBAU Act, 1994 is
yet to be notified.

The Babasaheb Bhimrao Ambedkar
University would provide instructional
and research facilities in frontier areas of
Technology and allied disciplines as well
as offer appropriate courses relevant for
the development of socially and
economically deprived sections of the
people.

Consequent upon the transfer of land
and other assets free of cost by the Govt.
of U.P. to the Central Government and
notification of date of commencement of
BBAU Act, University Grants
Commission would be in a position to
provide funds for the development and
maintenance of the University.

Gold Mines in Uttar Pradesh

areas located in those hills of Uttar
