under flood lighting despite the fact that such lighting has already caused damage to the Sun Temple at Konark; and

(c) whether in view of the above report, Government would reconsider its decision to flood lit monuments such as the Konark Sun Temple, Taj Mahal, Qutab Minar and various other medieval and British forts?
