257. SHRI SUSHILKUMAR SAMBHAJIRAO SHINDE: SHR1MATI VEENA VERMA:

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether Government's attention has been drawn to the report which appeared in the Hindustan Times of September 4, 1995 captioned, "Pakistan whipping up war-hysteria" quoting Pakistan's Prime Minister Ms. Benazir Bhutto and other leaders indulging in whipping up war-hysteria in india against Pakistan;
- (b) what utterances/incidents and provocations from Pakistani authorities have come to Government's notice during the last three months; and
- (c) what is Government's reaction thereto?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI R.L. BHATIA): (a) Yes, Sir,

- (b) Pakistan's support to trans-border terrorism, its efforts to raise the Kashmir issue at the international fora and its anti-India campaign continue unabated. These actions vitiate the atmosphere of bilateral relations between the two countries.
- (c) Government are committed to the normalisation of relations with Pakistan and have repeatedly conveyed their desire to resume direct bilateral talks without any preconditions. Pakistan has, as yet, not responded positively to Government's offer.

Reimbursement to SRPF Companies

260. DR. BAPU KALDATE: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that the Government of Maharashtra had requested for recovery of the dues from Central Government in respect of expenses Incurred for the Twelve SRPF companies deputed to New Delhi for internal security from May 1990 to August, 1993;
- (b) how much amount is to be paid by Central Government to Maharashtra Government in this regard;
- (c) the amount paid to Government of Maharashtra so far; and
- (d) by when the balance is proposed to be paid?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS

(PROF. MEIJINLUNG KAMSON): (a) and (b) A bill for Rs. 16,85,12,036'- has been raised against Delhi Police for Maharashtra State Reserve Police Force companies deployed in Delhi for assisting in law and order duties from 2.5.90 to 9.2.93. The bills for the remaining period have not yet been received by Delhi Police.

(c) and (d) The payment could not be reimbursed for want of certain documents from Government of Maharashtra, which have now been received. A proposal for obtaining expenditure sanction for Rs.4,92,54,831/- has been sent by Delhi Police to the Government of NCT of Delhi.

The Government of NCT of Delhi have approved the payment of remaining bills amounting *Rs.11,91,57,205/-*. Action
