Outdated Laws for protection of Wildlife

- 319. SHRI KRISHNA KUMAR BIR-, LA: Will the Minister of ENVIRON-MENT AND FORESTS be pleased to state:
- (a) whether Government's attention has been drawn to the press news-item captioned "Outdated laws threaten wild-life" as reported in "The Statesman" dated the 30 October, 1995.
- (b) if so, whether the wildlife is not being properly protected due to outdated laws:
- (c) whether there is spurt in sale of Zoo animals in the country; and
- (d) if so, the steps Government propose to take to bring amendments in the wildlife laws?

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI RAJESH PILOT): (a) Yes, Sir.

- (b) No, Sir. The wildlife (Protection) Act was enacted in 1972 and amended in 1986 and 1991 to make it more stringent and responsive to the current needs.
- (c) and (d) There has been no spurt in the sale of zoo animals in the country. Central Zoo Authority under this Ministry controls all transaction related to procurement, sale and transfer of zoo animals belonging to the Schedules of Wildlife (Protection) Act, 1972. However, this Ministry has recently set up an inter-state Committee to review the Wildlife (Protection) Act, 1972 and other related laws.

Repair/Maintenance of National High-ways in Andhra Pradesh

- (c) whether any work on the roads in Andhra Pradesh has been undertaken since the onset of monsoon; and

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI M. RAJASEKARA MURTHY): (a) to (d) A sum of Rs. 18.49 crores has been allocated during 1995-96 for annual repair/maintenance of National Highways in Andhra Pradesh. In addition, a further sum of Rs. 2.5 crores has been allocated to meet the cost of emergent repairs consequent to the, recent flood damages. All efforts are being made to maintain the National Highways in traffic worthy condition.
