Installation of a solvent Dewaxing Unit at Digboi Refinery in Assam.

SHRI BHADRESWAR BURAGOHAIN (ASSAM): Mr. Vice-Chairman, Sir, I would like to draw the attention of the Minister of Petroleum, through you, to a very important issue concerning my State of Assam.

Sir, the crude oil of Assam contains a significant quantity of high-quality waxes. Paraffin wax produced by Digboi refinery from the crude oil of Assam was exported for

number of years. But these sources of production of paraffin wax have not been fully exploited and, as a result, the country has to import regularly this high-value product. The situation, therefore, needs immediate attention

Sir, Asia's oldest refinery at Digboi has been producing paraffin since 1928. Its machineries have become old and outdated and their lives have expired long back. Its equipments and spare parts are not available in the market. It requires high involvement of hard manual labour. Interstingly, no investment has been made in this unit since 1972.

The existing process is neither energyintensive nor labour-intensive and it is energyinefficient. Most of the pumps are obsolete and their replacement is very difficult especially when their bodies have cracked. Six such pumps have been scrapped and the rest are running under critical conditions.

Breakdown of double pipe chillers is very frequent. Their annular space is getting blocked due to inherent impurities of brine and na/ariting supplying water, causing the cooling efficiency to considerably decrease.

In view of the above, the unii requires revamping. I would urge upon the Ministry of Petroleum and Natural Gas to inslai a Solvent Dewaxing Unit at the Digboi refinery. I understand that a proposal on the matter is pending with the Ministry for its approval. It should be cleared at the earliest possible.

Finally, I would request the Ministry not to send me a qualified and stereotype answer as is done in all other matters. I would like to have a positive and categorical reply from the Ministry.
