taken. Special Import Licence was a mechanism to allow import of certain restricted items but consequent to removal of QRs, the same has become redundant. The Duty Entitlement Passbook Scheme has not been abolished. RBI has also reduced the pre-post shipment export credit rate. Efforts are being made by the Customs to clear the pending cases of duty drawback and DEPB. For reducing the transaction cost, DGFT Offices have been computerised and electronic filing facility has been extended to reduce interface and transaction time. A large number of Custom houses have also been computerised. Most of the recommendations of the High Powered Committee on Transaction Cost have already been implemented. The setting up of the Agri-export zones would help in creation of infrastructure facilities for export of perishable commodities in the horticulture and floriculture sectors. A beginning has been made for the involvement Governments in the export facilitation exercise with a budgetary allocation of nearly Rs. 100 crores for disbursement to the States based on certain objective criteria.

## Free radio frequency to cellular operators

## Pending irrigation projects of Orissa

THE MINISTER OF WATER RESOURCES (SHRI ARJUN CHARAN SETHI): (a) to (c) Out of 178 irrigation projects received from various States in the Central Water Commission for technoeconomic appraisal, 99 projects had been accepted as on 31-3-2001 by the Advisory Committee of the Ministry of Water Resources, subject to certain observations.

22 Nos. irrigation projects have been received from the Government of Orissa, out of which 17 Nos. have already been accepted by the Advisory Committee of the Ministry of Water Resources, subject to certain observations. Remaining 5 Nos. of irrigation projects are in different stages of appraisal. The details of these projects are given in the Statement.
