for Industrial and Financial Reconstruction (BIFR). In terms of the Draft Scheme, the company is expected to wipe off its accumulated losses by 2003-2004. The share of the State Government according to the Draft Scheme is as follows:

- (1) To agree to waive sales tax differential for the period April, 1993 to March, 1994.
- (2) The continue charging concessional sales tax for fuel efficient vehicles of SML at par with other Indo-Japan competitors for the period of rehabilitation.

#### Office of the Chief Vigilance Commissioner

- 457. SHRI SATYA PRAKASH MALAVIYA: Will the PRIME MINISTER be pleased to state:
- (a) whether it is a fact that a key post has been lying unoccupied in the Office of the Chief Vigilance Commissioner;
- (b) if so, the reasons therefor stating the name of the post and time since it is lying vacant; and
- (c) the steps taken/likely to be taken by Government to fill the said post at the earliest?

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS (SMT. MARGARET ALVA): (a) to (c) The post of Central Vigilance Commissioner is lying vacant since 3.4.1995. Matter has received attention of Government and action has already been initiated to fill up the post at the earliest.

# Dispute between SSIs and Exporters over Sandalwood

- 458. SHRI V. HANUMANTHA RAO: Will the Minister of INDUSTRY be pleased to state:
- (a) whether there is an on-going dispute between small-scale industries using sandalwood dust and sandalwood and the exporters who bought sandalwood;

- (b) what is the area of dispute;
- (c) whether the same has been resolved;
- (d) whether any of the sandalwood in question is from Andhra Pradesh; and
  - (e) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI M. ARUNACHALAM): (a) No, Sir. The export of sandalwood in any form, but excluding fullyfinished handicrafts made of out sandalwood products are prohibited. There are no exporters of sandalwood.

(b) to (c) Do not arise in view of (a) above.
