conducting radiotherapy since it violated the safety norms required to conduct such tests; and

(b) if so, what are the reasons for not banning other clinics which are not following the prescribed rule?

THE MINISTER OF STATE IN THE PRIME MINISTER'S OFFICE (SHRI BHUVNESH CHATURVEDI): (a) Yes, Sir. As the Institution has not fulfilled the relevant radiation safety related requirements, the AERB issued a directive to ensure that the institution complies with all the requirements.

(b) AERB Monitors the radiation safety status of all hospitals by periodic review of safety reports from these hospitals and through inspections. The Board initiates appropriate regulatory action against those hopitals violating the safety provisions.

AERB has issued in June 1995 directives to the following five (5) hospitals to enforce the provisions of the Radiation Protection Rules, 1971, in view of the violations observed during the inspections carried out by the team appointed by AERB:

- 1. Medical College Hospital, Calcutta.
- 2. S.S.K.M. Hospital, Calcutta.
- 3. R.G. Kar Medical College Hospital, Calcutta.
- 4. N.R.S. Medical College Hospital, Calcutta.
- 5. Chittaranjan National Cancer Centre, Calcutta.

Suitable follow-up action are being taken in all the above cases.
