commercial activities of the private plants.

(c) MFIL is exploring the possibility of inccasing the sale of Rasika by introducing more flavours in larger size bottles of 300 ml each as well as in tetrapacks.

Article on Indo-Bangladcsh Relations

1136. SHRI ANANTRAM JAISWAL: SHRI SATYA PRAKASH MALAVIYA:

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether the attention of Government has been drawn to an article written by former Foreign Secretary, Shri J.N. Dixit under the heading India & Bangladesh—The treaty no one wants appearing in the 'Indian Express' dated the 4th July, 1995; and
- (b) if so, the reaction of Government and the steps taken/proposed to be taken by Government with regard to the matters described in the article?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SALMAN KHURSHID): (a) Yes, Sir.

(b) The views expressed by the former Foreign Secretary have been made in his own capacity and cannot be taken to reflect the views of the Government of India. The question of whether the Treaty of Friendship, Cooperation and

Peace of 1972 between India and Bangaldesh should be renewed, may be considered by Government at the appropriate time.
