the adminsitrative control of Ministry of Agriculture are given below:

- (i) NSC has its regional office located at Lallaguda, Sccunderabad (A.P.) in addition to four area offices located at Lallaguda, Warrangal, Guntur and Kurnool. Main operations of NSC in the State are production of breeder seed, foundation seed, certified seed, processing, packing, storage and sale of certified seeds through its sale counters and dealership network.
- (ii) The Corporation has also a 200 hectares farm located at Nandikotkur, District-Kurnool. The farm is producing breeder seed and foundation seed of a wide range of crop varieties.
- (iii) The Corporation has a Quality Control Laboratory in Secunderabad for testing samples received from its offices in Karnataka, Maharashtra, Tamil Nadu, Kerala and Madhya Pradesh.
- (c) No, Sir.
- (d) & (e) In view of the position indicated above, the question do not arise.

Shifting of Government and PSU Offices

- 1322. SHRI O.P. KOHLI: Will the Minister of URBAN AFFAIRS & EMPLOYMENT be pleased to state:
- (a) whether Government had identified some of the Government offices and the Public Sector Units to be shifted out of Delhi long time back:.
- (b) if so, how many *at* the identified offices have actually been shifted out of Delhi and by when will the remaining offices/units be shifted;
- (c) whether there is any proposal to ideitify more number of Government offices and public sector units for shifting out of Delhi; and
 - (d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN AFFAIRS & EMPLOYMENT (SHRI P.K. THUNGON): (a) Yes, Sir.

- (b) Three Government Offices and four Public Sector Units have been actually shifted out of Delhi. The actual shifting of Government offices/public Sector Units depends upon a number of determining factors like availability of land, construction of building etc. In view of this, no time frame can be set for actual shifting of the remaining Government, offices/Public Sector Units.
 - (c) There is no such proposal.
 - (d) Does not arise.
