(8) 10% of Government expenditure to be earmarked for education and also to remove gender biases.

Communalism, Religious Fundamentalism

- (9) Equal legal rights for women of all communities.
- (10) All Women's organisations must campaign against the dangers of communalism.

Violence Against Women

- (11) To remove gender bias from Government policies.
- (12) Demand for family courts.
- (13) Demand for association of Women's organisations for family courts.
- (14) To implement gender senitisation programmes.

Women and Law

- (15) In the area of family/personal laws, the Government should enact laws to give equal rights to women regardless of her religion.
- (16) Women workers both in organised and unorganised sectors be given minimum wages.

Women and Media

- (17) There should be a mechanism for sensitising the censor boards.
- (18) Instead of comprehensive censorship laws, Government must ensure that the existing laws are properly followed.
- (19) Media specialists should take steps to promote visual literacy.

Women and Family

- (20) A Comprehensive system of State social Security.
- (21) State to recongnise the existence of female-headed households in policy and administrative matters.
- (22) Ensure women's access to resources.
- (23) Non-wage female labour must be given social and economic recognition.

Political Participation of Women

(24) Reservation of seats for women should be provided in all elected bodies at all levels right upto Parliament.
