Under the Minimum Wages Act, 1948, both Central and State Governments are the appropriate Government for the fixation/revision and enforcement minimum rate of wages for the scheduled employment in Agriculture. The Act also provide for the fixation of working hours, weekly, days of rest and payment for overtime etc. The .Central Government as well as all the State Governments/Union Territory Administrations have fixed the minimum rate of wages and have framed rules in respect of agricultural workers. The Enforcement Machinery set up under the Act by the various appropriate Governments conducts regular inspections and necessary action is taken whenever any violation to the Act comes to their notice. The proposal for bringing forward a comprehensive bill for agricultural labour is under the active consideration of Government.

कोयला राज्य मंत्री (श्री अजित कुमार पांजा) : (क) से (घ) कोयला उद्योग के लिए संयुक्त द्विपीक्षीय समिति पर कामगारों तथा प्रबंधन के प्रति निधियों के बीच दिनांक 29.4.1995 को एक समझौता ज्ञापन पर हस्ताक्षर हुए, जिसमें राष्ट्रीय कोयला मजदूरी समझौता-5 की निम्न विस्तृत शर्ते, जैसे न्यूनतम मूल मजदूरी, वार्षिक, वेतनवृद्धि की दरें, वेतनमान न्यूनतम गारन्टी लाभ, भूमिगत भत्ते, अन्य भत्ते शामिल है। दोनों पक्ष समझौते के विस्तृत प्रावधनों पर विचार-विमर्श कर रहे हैं और इसके शीघ्र ही अंतिम रूप दिए जाने की संभावना है।

Action Plan to encourage consumer move-ment

1399. SHRI VIRENDRA KATARIA: Will the Minister CIVIL SUPPLIES, CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION be pleased to state:

THE MINISTER OF CIVIL SUP-PLIES, CONSUMER AFFAIRS AND **PUBLIC** DISTRIBUTION (SHRI BUT A SINGH): (a) to (d) The Government has taken a numbe*r of measures to increase consumer consciousness amongst people. Such measures include preparation .of audio visual material, printed literature in the form of booklets, brochures, posters, postcard size material etc. in the field of consumer protection. It is also publishing a quarterly journal "Upabhokta Jagaran" which disseminates useful information to the consumers. The printed material is made available to consumer organisations free of cost. In addition, Consumer Welfare Fund has been set up to give financial assistance to voluntary consumer organisations for undertaking activities in the field of consumer protection and promoting consumer movement in all parts of the country.
