

**P.F. deposits by Trading concerns**

1979. **SHRI MOHAMMED AFZAL ALIAS MEEM AFZAL:** Will the Minister of LABOUR be pleased to state:

(a) the number of trading concerns as on 31st March, 1995 which were to deposit more than five lakhs towards PF A/cs of the employees; and

(b) what are the names and amount of such concerns together with the outstanding amount?

**THE MINISTER OF LABOUR (SHRI P.A. SANGMA):** (a) and (b) As on 31.3.95, there were 679 establishments in the country which had P.F. default of more than Rs. 5.00 lakhs. As the number of such defaulters is quite large, it is somewhat difficult to furnish their individual details. At present, the information relating to default by the trading concerns is not separately maintained.

**Tobacco and Cigar workers in Andhra Pradesh**

**THE MINISTER OF STATE OF THE MINISTRY OF COAL (SHRI AJIT KUMAR PANJA):** (a) to (c) Geological Survey of India (GSI), engaged in regional exploration of coal

in the country, have established the following potential blocks with estimated reserves indicated against each in the virgin tracts of Talchar & Ib-River coalfields in Orissa:

1982. **श्री दिग्विजय सिंह:** क्या खाद्य मंत्री यह बताने की कृपा करेंगे कि:

(क) पिछले तीन वर्षों के दौरान तथा जुलाई, 1995 तक भारत में खाद्यान्नों की प्रति व्यक्ति प्रतिदिन/प्रति-माह उपलब्ध कितनी-कितनी रही है;

(ख) क्या यह सच है कि देश में प्रति-व्यक्ति खाद्यान्न की उपलब्धता में गिरावट आई है; और

(ग) यदि हां, तो इसके क्या कारण हैं; तथा सरकार प्रति-व्यक्ति खाद्यान्न उपलब्धता में आई कमी/गिरावट को पूरा करने के लिए क्या प्रभावी कदम उठाने पर विचार कर रही है?
