- (c) It is difficult to make any quantitative comparision between our private power policy and that of China. However, the response to our private power policy has been overwhelming which indicates that the policy has been found attractive by the investors.

- (i) Superhit Muqabla Rs 40 lakhs per episode.
- (ii) Junoon (Till May, 1995)—Rs. 23 lakhs (episode shown on Thursday).
- (b) No, Sir. Among non-film programmes, Junoon was the only serial on minimum guarantee. It was shifted to DD I as a part of restructuring of the

fixed point chart w.e.l. 2.6.1995 with a view to provide a new programme mix menu to viewers.
