#### Cement Plants

2412. SHRI BHAGABAN MAJHI: Will the Minister of INDUSTRY be pleased to state:

- (a) whether Government have a proposal to expand the capacity of some of the public sector cement plants;
- (b) whether Government also propose to set up some new cement plants in Orissa; and
- (c) if so, the places selected for this purpose?

THE MINISTER OF STATE IN THE MINISTRY **INDUSTRY** OF (SHRIMATI KRISHNA SAHI): (a) No, Sir. There is no proposal to expand the capacity of the plants of Cement Corporation of India Ltd. (CCI), which is the only Central Public Sector Undertaking in the Cement Industry.

### Malaria and Gastro-Enteritis in Assam

2413. SHRI **BHADRESWAR** BURAGOHAIN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to refer to the answer to Unstarred Question 517 given in the Raiva Sabha on the 3rd August, 1995 and state:

- (a) whether Government are aware that the gravity of malaria and gastroenteritis in Assam has created the situation of death for all in Assam at present; and
- (b) whether Government have chalked out any emergency action plan to eradicated malaria and gastro-enteritis in Assam?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH & FAMILY WELFARE (DR. C. SILVERA): (a) The outbreak of Malaria which took place in some districts of Assam during April-May, 1995 has been controlled. No report has been received about outbreak of gastro-enteritis from the state during 1995.

(b) The malaria situation in the State is being constantly monitored and reviewed by the Centre and the State Government at various levels. Central Govt, has been providing 100% assistance to the State under National Malaria Eradication Programme (NMEP) since December, 1994 Necessary material and equipments have also been supplied to the State. Similarly for tackling the out break of diseases like gastro-enteritis, technical assistance for instituting containment measures is provided as requested by the State Government.

- (e) whether Government are aware that the Government of Assam are not following the criteria laid down for spending the funds; and
  - (f) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL AREAS & EMPLOYMENT (SHRI UTTAMBHAI H. PATEL): (a) Integrated Rural Development Programme (IRDP) Jawahar Rozgar Yojana (JRY) are major rural development schemes being implemented in various districts of Assam. A Statement showing the funds provided under the above schemes in various districts of Assam during last two years and current financial year is at Statement I & II. (See below) (b) to (d) The financial and physical achievements reported by the State of Assam under IRDP & JRY during 1993-94 & 1994-95 are as follows:—

# लू लगने से हुई मौते

2415. **झी राघवजी:** क्या प्रधान मंत्री यह बताने की कृपा करेंगे कि:

(क) क्या यह सच है कि वर्ष 1995 में अत्याधिक यमीं के कारण हुई मौतों की संख्या पूर्व वर्षों की तुलना में बढ़ गई है और पिछले तीन वर्षों के दौरान लू लगने से हुई मौतों का तुलनात्मक ब्यौरा क्या है; और

(ख) इस वर्ष ऐसी मौतों में वृद्धि होने के क्या कारण थे, क्या इतनी अधिक गर्मी पड़ने के संबंध में पूर्वानुमान लगाया गया था, यदि हां, तो सरकार द्वारा इसका मुकाबला करने के लिए क्या तैयारियां की गई थीं, यदि इसका पूर्वानुमान नहीं लगाया गया था, तो इसके क्या कारण थे?

प्रधान मंत्री कार्यालय में राज्य मंत्री तथा परमाणु कर्ना, अंतरिक्ष विभागों तथा विज्ञान और प्रौद्योगिकी मंत्रालय में राज्य मंत्री (श्री भुवनेश चतुर्वेदी): (क) और (ख) प्रेस रिपोटों के अनुसार, 1993, 1994, 1995 में लू लगने से क्रमशः 42 एवं 371 और 452 मौतें हुई। गर्मी के महीनों में अनियमित वायुमण्डलीय प्रवाह पैटर्न की वजह से अत्यधिक लू चली जो इस मौतों की जिम्मेदार है। भारत मौसम विज्ञान विभाग द्वारा गर्म लू की सूचना 24 से 48 घंटे पहले दे

दो गई थी। स्वास्थ्य एवं परिवार करूपाण मंत्रालय के विभिन्न स्वास्थ्य शिक्षा कार्यक्रमों में, लोगों के मार्गदर्शन हेतु विभिन्न आपात स्थितियों में, जिनमें लू लगने से उत्पन्न होने वाली स्थितियां शामिल हैं, क्या करना चाहिए और क्या नहीं करना चाहिए बताए जाते हैं।

## प्राचीन चिकित्सा पद्धति

क्या स्वास्थ्य और परिवार करूचाण मंत्री 16 मार्च, 1995 को राज्य सभा में तारांकित प्रश्न संख्या 61 के दिए गए उत्तर को देखेंगे और यह बताने की कृपा करेंगे कि देश में आयुर्वेदिक, यूनानी, होम्योपैथी और अन्य प्राचीन चिकित्सा पद्धति के अनुसंधान संवर्धन और विकास हेतु सरकार द्वारा क्या भावी योजनाएं निरुपित की गई है?

स्वास्थ्य और परिवार करूयाण मंत्रालय में राज्यमंत्री (डा॰ सी॰ सिल्वेरा): सरकार ने भारतीय चिकित्सा पद्धति और होम्योपैधी का एक अलग से विभाग स्थापित करने की हाल ही में घोषणा की है। इस विभाग को स्थापित करने का मुख्य उद्देश्य भारतीय
