Promotion of Khadi and Village Industries

2397. SHRI SANATAN BISI: Will the Minister of INDUSTRY be pleased to state:

- (a) what is the outlay for 1995-96 for promoting Khadi and Village industries;
- (b) what is the target for providing employment in this area for 1995-96; and
- (c) what is the production output and employment soon after the implementation of the action plan on October 2, 1994?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI M. ARUNACHALAM): (a) The total Plan Outlay for 1995-96 for promoting Khadi and Village Industries is Rs. 343 crores.

- (b) The target for providing employment in the Khadi & Village Industries Sector for 1995-96 is 3.52 lakhs of persons.
- (c) The schemes are at various stages of implementation.

(c) to (f) The Government is making special efforts for expediting settlemlent of insurance claims of the Kashmiri migrants keeping in view their urgent needs. The Government will continue to monitor the process to further improve the position.
