

into the Consolidated fund of India releasing only five per cent of the amount for the development of the particular industry as in the case of OID.

THE VICE-CHAIRMAN (SHRI TRILOKI NATH CHATURVEDI): The Minister assures that this will really be spent for the purpose for which the Bill has been moved and a mechanism will be worked out to ensure what you suggested.

SHRI SATISH AGARWAL: The Chair is satisfied; the House is satisfied. I am with the House. in view of the assurance, we will take it up in the Assurances Committee. The assurance given by the hon. Minister is that the cess collected under this particular Act shall be utilised exclusively for the welfare of the workers and the employees and that it shall never be utilised for Government expenditure. I seek leave of the House to withdraw my motion.

THE VICE-CHAIRMAN (SHRI TRILOKI NATH CHATURVEDI): Mr. Agarwal, Government represents continuity in regard to any assurance. Naturally that will be followed by all others.

The motion for reference of the Bill to Select Committee was, by leave, withdrawn.

Shri V. Narayanasamy: When it is withdrawn it need not be put for voting. It is withdrawn with the leave of the House. Therefore, it need not be put for voting.

The Vice-Chairman (Shri Triloki Nath Chaturvedi): So it -need not be negated. The hon. Members were speaking about the assurance again and again. So I thought let us be doubly sure and the Minister's assurance will also, be then reinforced accordingly. The Members have also some other viewpoints to suggest because there is another connected Bill, the Building and Other Construction Workers Bill. The Minister has moved both of them.
