The Bill was introduced there by me with the permission of the Speaker, and the House was adjourned to enable a conscious decision to be taken by all Opposition parties. After they come to some agreement, the Bill will be taken up for discussion and it will be passed. This is the understanding in the other House.

Here also, if you permit me, I will introduce the Bill. Then you can call senior leaders of all political parties. Whatever decision is going to be taken in the meeting of all party leaders, we can implement it here itself. I Just wanted to
