Financing the parks and recreational areas

1903. SHRI V. HANUMANTHA RAO: Will the PRIME MINISTER be pleased to state:

(a) whether there is any proposal to finance parks and recreational areas in cities, towns and urban habitats;

(b) if so, the details thereof;

(c) whether Government have extended any such assistance to any township in Andhra Pradesh; and

(d) if so, the details thereof

THE MINISTER OF STATE IN THE MINISTRY OF URBAN AFFAIRS AND EMPLOYMENT (DR. V. VENKATESWARLU): (a) Yes, Sir.

(b) A proposal for introducing a Centrally Sponsored Scheme of City/Urban Forestry has been formulated by the Ministry of Urban Affairs & Employment and has been circulated to the Ministry of Environment & Forests and the Planning Commission for comments. The proposal seeks to promote city forests, green belts, woodlots, etc., based on a partnership between Central and State Governments and certain town level reforms. In addition, under the Centrally sponsored Scheme of infrastructural development in Mega Cities, the development of parks and recreational areas can be considered by the concerned State Governments.

(c) and (d) Under the Mega Cities Scheme, an amount of Rs. 41.5 crores has been allocated to Andhra Pradesh as Central assistance during 1993-96 for undertaking various urban development programmes, including development of parks and recreational areas. The Hyderabad Urban Development Authority is the nodal agency for implementation of the Scheme.

Oil and gas search by US in eastern part of the country
