## **Report of Oza Commission**

2030. SHRI MATANG SINH: Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that the Oza Commission was set-up to look into the matter of safeguarding the interests of residents along the stretch of alignment of construction of Konkan Railway; and
- (b) whether it has submitted any report and if so, the details thereof and the action taken by Government thereon?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) No, Sir. It was set up for examining the objections by the environmentalists to the alignment to be followed by the Konkan Railway in Goa.

(b) Yes. Sir. Oza Commission submitted its report in Oct.'93. The major recommendations were for construction of viaducts in place of embankment for all banks higher than 10 mtrs., provision of additional flood openings and passages lor fishing canoes in the Khazan lands, provision of fencing/over bridges and under bridges at certain locations, antivibratory measures in the Old Goa tunnel to save the Church on the hill top from damage, slight shifting of the alignment in the Old Goa tunnel, landscaping of the damaged hill on Dewar island, etc. The report has been accepted by the Government in toto and is being implemented in full.

(b) to (d) Three cases in Kendriya Vidyalaya, New Mehrauli Raod, New Delhi and ten cases in Kendriya Vidyalaya punjab Lines, Meerut, of admission on fake transfer certificates have been reported. Four employees involved in these admissions have been transferred out of Kendriya Vidyalaya New Mehrauli Road, New Delhi, as a preliminary step. Assistant Commissioner concerned has been requested to get an enquiry conducted in the matter. His report has not been received.
