THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) The information furnished by the National Open Schools (N.S) regarding students enrolled by it. during last 3 years in different States/UTs is given in the enclosed Statement-I (See below)

(b) The list of Study Centres (Accredited Institutions) of NOS in different States/UTs as on 2.7.1996 is given as Statement.II. (See below)

(c) and (d) NOS has informed that due in a proudurla dilay, two Universities and to Kamataka, vis., Gulbarga University. Mysore University,

Kamataka board of Pre-University Education and Kamataka Secondary Education Examination Board have yet to recognise NOS courses. NOS is pursuing the matter with these Universities/Boards for expeditious recognition whose response is awaited by the Government.
