Vocationalisation of Higher Secondary Level Education

1996. SHRI GOVINDRAO ADIK: Will the Minister of HUMAN RE-SOURCE DEVELOPMENT be pleased to state:

- (a) Whether Government are aware of the study conducted by the PSS Central Institute of Vocational Education of his Ministry which highlights the need for top priorty attention to vocationalise higher secondary level education for imparting training to middle-level manpower requirement in the agriculture sector; and
- (b) if so, the details of the study and the reaction of Government thereon?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RE-SOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) and (b) No. Sir. However Pt. Sunderlal Sharma Central Institute of Vocational Education has published a compendium entited "Skilled manpower in agriculture; prospects and modalities for development". The technical papers included in compendium deal with the prospects of vocational education and manpower requirements at the middle-level in various sectors of agriculture.

Repair of Monuments

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI S.R. BOMMAI): (a) to (c) The maintenance and conservation of centrally protected monuments is a condinuous process. The centrally protected monuments are managed by the Archaeological Survey of India through its Circle Offices spread all over India, these monuments are inspected regularly by the Officers from the Circles/Branches as well as from the Directorate. Conservation measures are taken up according to actual needs of individual monuments and as per the availability of resources. For the current financial year about 300 centrally protected monuments have been proposed for comprehensive repairs.
