- (ii) requisite pirce support to the be provided through growers market intervention/open market purchases of copra the designated Central and State agencies during the peak marketing period of the 1996 season.
- (c) Yes, Sir.
- (d) The Government has decided to continue the procurement of copra during 1996 season at the Minimum Support Prices of 1995 season i.e. Rs. 2500 per quintal for milling copra (FAQ) and Rs. 2725 per quintal for ball copra (FAQ).
