# CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION be pleased to state:

- (a) the quantity of foodgrains supplied through the PDS throughout the country during the last three years, and its percentage with regard to the total consumption of foodgrains, details Statewise and year-wise; and
- (b) the price of the foodgrains sold through PDS during the last three years, year-wise and the price of the same foodgrains in the open market, in various States?

THE MINISTER OF FOOD AND MINISTER OF CIVIL SUPPLIES, CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION (SHRI DEVENDRA PRASAD YADAV): (a) The allocations and of-take of foodgrains through PDS during the years 1993-94, 1994-95, and 1995-96 are shown in Annexure [See Appendix 178, Annexure No. 631. It is stated that the allocations through Public Distribution System are supplemental in nature and are not intended to meet the entire requirements of States/UTs. The States and UTs also make available foodgrains on their own, besides open market availability. There may be inter-State movement of foodgrains also. Thus the exact quantum of consumption of foodgrains in each State cannot be worked out.

(b) The year-wise Central Issue Price (C.I.P) of foodgrains during the last 3 years is as under:—

THE MINISTER OF STATE OF THE MINISTRY OF COAL (SHRIMATI KANTI SINGH): (a) Demand of coal for the year 1994-95 and 1995-96 as assessed by the Planning Commission and the actual production of coal for these two years are as under:

- (b) Steps taken to increase coal production in the country are as follows:
  - (i) Opening up of new mines and increasing efficiency and productivity in existing mines by modernisation, application of new technologies and ensuring timely availability of inputs and infrastructural facilities.
  - (ii) The capital base of Coal India Limited has been restructured to enable it to raise from the capital market additional financial resources which are required to add to new coal production capacity.
  - (iii) Co-ordination on continuous

basis with the Railways is maintaind to remove transportation bottlenecks in such coalfields area which have potential for enhanced production.

- (iv) Private sector companies engaged in production of iron and steel, cement and generation of power have been permitted to take up coal mining for their own use. This is expected to increase domestic coal production.
- (v) Modification of existing washeries as well as construction of new washeries are being taken up to increase the availability of washed coking coal.
