Central Assistance for cane Development and Modernisation

2836. MISS SAROJ KHAPARDE: Will the Minister of FOOD be pleased to state:

- (a) whether Central fiancial assistance is provided by Government to the sugar sector for cane development and Modernisation:
 - (b) if so, the details thereof;
- (c) details of the central financial assistance provided in the state of Maharashtra to the sugar sector for cane development and modernisation during the last three years, year-wise; and
- (d) whether Government propose to increase the Central assistance to the State for the purpose?

THE MINISTER OF FOOD AND MINISTER OF CIVIL SUPPLIES, CONSUMER AFFIARS AND PUBLIC DISTRIBUTION (SHRI DEVENDRA PRASAD YADAV): (a) and (b) Loans from Sugar Development Fund are provided for cane Development and Modernisation schemes. Till 30.6.96, 342 Sugar Factories were sanctioned Rs. 458.91 crores and Rs. 276.46 crores was disbursed for Cane Development, while 156 Sugar Factories were sanctioned Rs. 542.21 crores and Rs. 472.38 crores was disbursed for modernisation.

- (d) Since loan for Cane Development and Modernisation/rehabilitation depends upon the number of applications received, the quantum of assistance provided varies accordingly.
