to Questions

- (d) whether Government have accepted all the recommendation of the Aggarwal Committee;
- (e) if so, whether Government propose  $\wp$  implement them; and
  - (f) if not, the reasons therefor?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRI C.M. IBRAHIM): (a) and (b) The Expert Group constituted to review the provisions of Prasar Bharati Act, 1990, has submitted its report recently. Further action on the recommendations contained in the report, would be taken after consultations with representatives of political parties, media and employees' associations.

- (c) Aggarwal Committee has suggested the creation of a "Management Pool" comprising officer from Programme, Engineering and News cadres.
- (d) to (f) Government have accepted most of the recommendations made by the Committee and a decision has also been taken to implement the same. Only six out of the total ninety-eight recommendations, have not been accepted. Implementation of some of the recommendations would depend upon the requirenments and availability of resources from time to time.

#### Transfer of Central Excise and Custom Inspectors

2899: DR. D. VENKATESHWAR RAO: Will the Minister of FINANCE be pleased to state:

- (a) whether the enmass transfer of 151 inspectors of Central Excise and Customs has paralysed the work in the Commissionerate, its range Offices and the Air Cargo Complex in Hyderabad;
- (b) if so, what are the main reasons for the transfers;
  - (c) what are their demands; and
- (d) what steps have been taken to restore the work which has greatly affected the State Government?

THE MINISTER OF FINANCE (SHRI P. CHIDAMBARAM): (a) to (d) The transfer of Inspectors issued in the common-cadre Commissionerates of Hyderabad, Guntur and Vichakhapatnam, in April 1996 was an annual carried transfer order; which included 17 tespectors who were transferred to Guntur/ vishakhapatnam Commissionerates. The main demand was for stay of transfer orders by the Inspectors of Hyderabad. The order has been reviewed and the general transfer order has been implemented barring a few inter-Commissionerate transfers from Hyderabad to Vishakhapatnam and Guntur Commissionerate. The transfer did not affect the work of the State Government and the revenue collection at all.

# Lending by Public Sector Banks 2901. SHRI NAGMANI: SHRI ISH DUTT YADAV:

Will the Minister of FINANCE be pleased to state:

- (a) the total lending of Public Sector Banks as on date of annual closing, bankwise, and during the last three years and the shares of lending to small farmers with details of number of accounts/amount outstanding for each bank during the period;
- (b) whether Government have issued any instructions to public sector banks regarding fixation of any target amount and number of accounts for lending to small farmers in any given years; and
- (c) if so, the details thereof and the steps being taken by Government to increase the ratio of lending to small farmers?

THE MINISTER OF FINANCE (SHRI P. CHIDAMBARAM): (a) to (c) The information is being collected and will be laid on the Table of the House.

#### Steps taken by Government to reduce Maternal Mortality Rate in the country

2902. SHRI RAMDAS AGARWAL: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether Government's attention has been drawn to a study report of World Bank that "maternal mortality rates in India's rural areas are among the highest in the world" and "maternal health strategy as far to go" as reported in the Times of India dated 24.6.1996;

- (b) if so, the details thereof and reasons therefor; and
- (c) what steps Government have taken so far to improve India's health agenda particular "reproductive health" and "low fertility" with reported World Bank's loan of 350 millions proposed to be given to India?

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI SALEEM IQBAL SHERVANI): (a) and (b) Yes, Sir. The Maternal Mortality Rate in rural areas was reported to be 448 per 100,000 live births by the National Health Survey (1992-93). Factors responsible for high maternal mortality rate in rural reas, inter alia, include low socio-economic status, inaccessability or to health services and inadequate infrastructure.

(c) Government propose to launch the Reproductive and Child Health Project with assistance from the World Bank in 1997. Preparatory work on the project proposal has been completed and a World Bank Appraisal Mission is expected to appraise the project later this year. The amount of loan is not yet finalised.

# WB assistance for development of intensive agriculture

2903. SHRI LACHHMAN SINGH: Will the Minister of FINANCE be pleased to state:

- (a) whether World Bank provides any financial assistance for the development of intensive agriculture;
- (b) if so, the details of assistance provided during the last six months;
