**Housing Finance Companies**

2942. SHRI VAYALAR RAVI:

Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that many housing finance companies with dubious credentials are

functioning in the country and cheating the people;

(b) whether Government have made any enquiry in this regard;

(c) if so, what action has been taken against such companies; and

(d) the steps taken to prevent these companies in committing frauds against the customers?

THE MINISTER OF FINANCE (SHRI P. CHIDAMBARAM): (a) to (d) The National Housing Bank (NHB) has reported that as a result of inspection and other checks carried out by them, instances of some housing finance companies committing irregularities and flouting prescribed norms have come to their notice. Show cause notices have been issued to 25 such companies for immediate corrective steps. NHB has further reported that in the case of six housing finance companies which have been persistently defaulting, prohibitory orders have been issued restraining them from accepting any further deposits from the public and ensuring the safety and security of existing deposits held by them. NHB has also launched criminal proceedings in the case of one housing finance company which was found to have disobeyed the prohibitory orders. Apart from its normal regulatory and supervisory functions, the National Housing Bank carries out off-site surveillance, particularly in the case of housing finance companies with net-owned fund of Rs. 50 lakhs and more.
