colleges by the State Governments and the Central Government to meet the increased demand of doctors in the country;

- (c) whether the policy of the Central Government and State Governments is to depend on private medical colleges for medical education: and
- (d) if not, what steps Government propose to take for setting up new medical colleges in government sector?

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI SALEEM IQBAL SHERVANI): (a) Nine medical colleges have been permitted to be set up in the country including two Govt. medical colleges in the State of Gujarat during the last three years.

(b) to (d) There is no proposal to set up new medical colleges by the Central Govt. As per information available, the doctor-population ratio comes to about 1:2200. However, taking into account the availability of registered medical practitioners from other systems of medicine like Ayurveda, Homoeopathy, Unani etc. numbering to 5.6 lakhs the ratio comes to about 1:950.

This figure compares favourably with a number of developing and other middle grouped countries of the world. Applications seeking permission of the Central Govt. for setting up new medical colleges are considered under the provisions of the Indian Medical Council Act, 1956 as amended.

Development of Buddhist sites in Bodh Gaya for Tourism

2969. SHRI PREM CHAND GUPTA: Will the Minister of TOURISM be pleased to state:

- (a) what steps have been taken by Government for development of Buddhist sites particularly Bodh Gaya for tourism;
- (b) if so, whether Government have taken adequate steps to popularise these sites to attract tourists; and
- (c) what is the number of tourists that have visited these sites in the last two years?

THE MINISTER OF PARLIAMENTARY AFFAIRS AND MINISTER OF TOURISM

- (SHRI SRIKANTA JENA): (a) The Government of India has signed two soft term loan agreements with the Overseas Economic Cooperation Fund, Japan for the development of infrastructure in the Buddhist circuit, the details of which are as follows:--
 - (i) 7.76 Billion Yen for infrastructural development along identified Buddhist circuits in U.P. & Bihar including Bodhgaya.
 - (ii) 3.75 Billion Japanese Yen for conservation and tourism development plan for Ajanta & Ellora in Maharashtra.

In addition, the Department of Tourism, Govt. of India has sanctioned the following schemes /projects for development of tourist facilities in Budhgaya:
