

(c) the number of new bank-branches proposed to be set up in private sector in Maharashtra, Gujarat, Orissa and Madhya Pradesh?

THE MINISTER OF FINANCE (SHRI P. CHIDAMBARAM): (a) With a view to promoting rural savings as well as providing credit for viable economic activities in local areas, Reserve Bank of India (RBI) have decided to allow establishment of new local area banks in the private sector.

(b) Guidelines relating to the setting up of local areas banks were issued by the RBI on August 24, 1996 and hence the receipt of applications in accordance with RBI's guidelines is expected to take some time. According to RBI some persons have expressed interest.

(c) RBI has not received any proposals for setting up of private banks in the rural areas in the states of Maharashtra, Gujarat, Orissa and Madhya Pradesh. However, private sector banks, which were established in pursuance of guidelines issued by the RBI on 22.01.93, have proposed to open branches in the states of Maharashtra, Gujarat, Orissa and Madhya Pradesh as detailed below:

None of these proposals are for opening branches in rural centres.

Aids and Leprosy Eradication Centres

*452. SHRI MOHINDAR SINGH KALYAN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) the number of AIDS Centres and leprosy eradication centres in operation in different parts of the country particularly in Punjab, district-wise details thereof;

(b) the amount of financial assistance sanctioned and released to each of these centres by Government during each of the last three years;

(c) whether any free treatment is being given by these centres to the patients; and

(d) if so, the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI SALEEM IQBAL SHERVANI): (a) There are no recognised AIDS centres in the country.

Annexure indicating the number of Leprosy centres in different States/UTs and in districts of Punjab are placed on the table of the House. [See Appendix 178, Annexure No. 69 and 70]

(b) Cases of AIDS are attended to in major hospitals along with other patients. As such no separate allocation/assistance is being provided for the AIDS cases. However, details of funds released to States/UTs for the various activities under National AIDS Control programme during the last three years are placed on the table of the house [See Appendix 178, Annexure No. 71]

Financial assistance is given to the States/UTs on quarterly basis so far as Leprosy Eradication Centres are concerned. Further, centre-wise allocation is done by the State Governments. Details of the amount sanctioned and released to various States/UTs during the last three years are placed on the table of the House. [See Appendix 178, Annexure no. 72]

(c) and (d) Yes, Sir. Free medical care is given to all the AIDS patients like other patients admitted in the hospitals.

Similarly, free treatment is provided to leprosy patients in all the districts of the country including districts of Punjab State.
