Treatment for the Disease systemic Lupus Erethematosis

(a) what is the treatment available in Allopathy, Homoeophathy. Unani and Ayurvadic for the disease 'Systemic Lupus Erethematosis' clubbed with fever; (b) the dispensaries and hospitals in the country where the treatment is available;

(d) if so, the details in this regard?

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI SALEEM IQBAL SHERVANI): (a) to (d) There is no known cure for Systemic Lupus Erethematosis in Allopathy and Ayurveda and only palliative treatment is available to reduce the pain and other manifestations of the disease. Homoeopathy and Unani System of medicine also treat the disease in accordance with their principles on the basis of symptoms and other relevant factors. Treatment is available in Central Govt. Hospitals and in Homoeopathic/Unani/ Ayurvedic Hospitals and Dispensaries.

Facilities at Tuberculosis centres in Gujarat

(a) the number of District Tuberculosis Centres, Peripheral Health Institutions and TB Clinics presently functioning in various part of Gujarat with district-wise details;
