- (b) Government is implementing a Scheme of Assistance to Voluntary Organisations for Prohibition and Drug Abuse Prevention under which grant-in-aid is given to voluntary organisations for providing services such as identification, treatment, counselling, followup, rehabilitation, awareness education etc. for drug abuse prevention, besides education work for prohibition. The provision is made under this Scheme to assist universities including schools of social work or such other institutions of higher learning also. 90% of the cost of project is borne by the Govt. of India. In addition, the Ministry of Welfare is also engaged in educating the Masses and creating Public Awareness about Drug Abuse Prevention through mass media including advertisements, Radio, Video spots/Quickies, Films and educative print material.
- (c) Narcotic Drugs and Psychotropic Substances Act, 1985 provides for death penalty in cases of certain second offences.
- (d) State-wise information of convictions is not maintained. However, the following number of convictions were reported to the Narcotics Control Bureau:
