- (b) the objectives/agreements of each accord with the concerned parties;
- (c) whether Government are contemplating a new strategy to deal with the situation; and
- (d) whether Government have taken any action on the purported statement of one of the strongest Naga .underground leader on the ongoing peace process?

THE MINISTER OF HOME AFFAIRS (SHRI INDERJIT GUPTA): (a) and (b) To restore peace and harmony, the accords were signed with the representatives of the Nagas (November 1975/January 1996), Mizo National Front (June 1986) and Tripura National Volunteers (August 1988).

(c) and (d) The Government of India categorically rejects violence as a means of achieving any objective. It believes in solution of problems through talks and negotiations. It is prepared for talks with any group which is willing to work within the framework of the Constitution of India and abjure violence.

Widening of National Highway No 27 into Four Lanes

THE MINISTER OF SURFACE TRANS-PORT (SHRI T. G. VENKATRAMAN): (a) No, Sir.

THE MINISTER OF COMMUNICATIONS (SHRI BENI PRASAD VERMA): (a) and (b) No confirmed incidence has been reported in this regard.

- (c) There is no such proposal.
- (d) Does not arise in view of (a) and (b) above.

Shortage in MES stores at Jabalpur

3111. SHRIMATI MALTI SHARMA: SHRI RAJ NATH SINGH:

Will the Minister of DEFENCE be pleased to state:

- (a) whether it is a fact that some shortage was found in the MES Stores, Jabalpur some three years back;
- (b) whether it is also a fact that only one Store Keeper was made the scape goat and was awarded punishment of compulsory retirement:
- (c) if so, the reasons for sparing others and whether the representation given by the affected party has been decided by the authorities; and
- (d) if so, the results thereof and if not, the reasons for such delay in deciding the case?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI N.V. N. SOMU): (a) No, Sir. However, certain financial irregularities, fraud payment and maladministration of contract in the Office of Garrison Engineer (West), Jabalpur in respect of work orders supply orders pertaining to the years 1989-90 & 1990-91 were noticed.

- (b) No, Sir, Five employees including one Store-Keeper were found responsible for the lapses/irregularities.
- (c) and (d) None of the persons found responsible for the lapses/irregularities has been spared. The representation of the Store-Keeper has since been decided and the penalty imposed upon him has been set aside.

Allocations of Funds for maintenance of national Highways

- 3112. SHRI GOVINDRAO ADIK: Will the Minister of SURFACE TRANSPORT be pleased to state:
- (a) whether Government of Maharashtra and other State Governemtn's have been repreatedly making representations pointing out inadequate allocations for original construction, maintenance and repairs of National Highways;

THE MINISTER OF SURFACE TRANS-PORT (SHRI T. G. VENKATRAMAN): (a) to (c) Various State Governments, including Maharashtra, have been demanding, from time to time, additional allocation. However, it has not been possible to meet their demands fully due to the continued resource crunch both for development and maintenance of National Highways. Nevertheless, efforts are made to keep the national Highways in traffic worthy conditions within the available resources. An amount of Rs. 1920.00 laksh for development of National Highways and Rs. 2457.00 lakhs for maintenance (excluding flood damage repair and special repair) have been earmarked for the State of maharashtra during the year 1996-97.
