Removing faults of Telephones

- 3041. SHRI NARESH YADAV: Will the Minister of COMMUNICATIONS be pleased to state:
- (a) whether he had assured attendance of telephone complaints within two days and transfer of telephones from old to new residence within 15 days:
- (b) whether the unattended complaints of telephones are published in newspapers;
- (c) if so, the action taken to remove such faults till date;
- (d) whether in spite of lapse of three months, many telephones have not been shifted to their new residence; and
- (e) if so, action taken against MTNL and by when the telephones are likely to betransferred?

THE MINISTER OF COMMUNICA-TIONS (SHRI BENI PRASAD VERMA): (a) Yes, Sir. A fixed target of 48 hours has been fixed for attending of telephone complaints and 15 days for shifting of telephones from old residence to new residence.

- (b) There is no system to publish unattended complaints in newspapers.
- (c) Special monitoring is done for such cases and these faults are cleared promptly.
- (d) Shifting of telephones is carried out within the Specified norms subject to technical feasibility. In same cases, due to technical non feasibility, the Shifts are delayed beyond the norms
 - (e) Does not arise in view of (d) above.

(b) The development of the North-Eastern region has been receiving constant attention of the Government. The North-Eastern Council, which was established by an Act of Parliament, is an important instrument of planning and for securing the balanced development of the North-Eastern region. Governors and Chief Ministers of the North Eastern States are the members of the Council.

Flood on River Ravi
