## Transport facilities in national waterway No. 2

THE MINISTER OF SURFACE TRANS-PORT (SHRI T. G. VENKATRAMAN): (a) to (c) A study was carried out during 1990 by the Inland Waterways Authority of India (IWAI) to identify the developments to be carried out on the river Brahmaputra. This project report recommended development of river Brahmaputra for navigation in 4 phases depending upon traffic projections. The

development includes maintenance of fairway, provision of cargo handling facilities including terminals etc. The declared stretch is being developed for shipping and navigation accordingly, keeping in view the cargo offering.
