

**Drought prone districts in Andhra Pradesh**

DR. MOHAN BABU:

Will the Minister of AGRICULTURE be pleased to state:

(a) the susceptible drought-prone districts in Andhra Pradesh;

(b) the assistance rendered to the State during the last three years, year-wise to carry out relief to drought victims; and

(c) further assistance proposed to be given as requested by the State Government to construct houses for the victims?

THE MINISTER OF AGRICULTURE (SHRI CHATURANAN MISHRA): (a) Eleven districts namely Adilabad, Chittoor, Cuddapah, Kumool, Khammam, Medak, Mahabubnagar, Nalgonda, Prakasam, Rangareddy and Srikakulam have been identified as drought-prone districts in Andhra Pradesh. In addition Anantpur district is covered under the Desert Development Programme.

(b) The following amounts were released to the State Government as Central share of Calamity Relief Fund for carrying out the relief measures in the wake of natural calamities including drought:—
