Production of medicinal plants in Gujarat

(a) whether the rural poor, particularly the tribal people are being encouraged in the State of Gujarat to produce medicinal plants to raise their income and living standard;

- (b) if so, what are the details thereof; and
- (c) what incentives are being given to the rural poor of the State for this purpose?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT & FORESTS (Capt. JAI NARAYAN PRASAD NISHAD): (a) No specific scheme is being implemented to encourage rural poor including tribals to produce exclusively medicinal 100% assistance under the centrally sponsored scheme for conservation and development of non-timber forest produce including medicinal plants to Government of Gujarat.

- (b) Does not arise.
- (c) The main objective of the centrally sponsored scheme referred in (a) is to provide additional income to the tribals and the rural poor living in and around forests by providing them direct employment as well as augmenting their income by producing non-timber forest produce including medicinal plants. During last three years, Gujarat Government have been given Rs. 398.10 lakh as central assistance under the scheme.
