"Shrimp Farm Trade in Tamil Nadu"

3247. SHRI R. MARGABANDU: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state; the reasons for encouraging the shrimp farm trade in Tamil Nadu despite destruction of several agricultural lands and health hazards casused by it?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (CAPTAIN JAI NARAYAN PRASAD NISHAD): Shrimp farming has only been encouraged in specific areas which.helps in optimal utilisation of brackish fallow lands in coastal regions which would otherwise have remained unutilized or under utilized. Not only docs this generate additional employment for people in the concerned rural areas, it also helps to generate valuable foreign exhange earnings. The union Ministry of Agriculture has issued guidelines in August, 1995 for development of sustainable aquaculture to reduce the adverse impact of waste treatment and promote other mitigation measures.
