

नियंत्रित स्थितियों के अन्तर्गत कैट मछलियों के उत्प्रेरित जीवों का संवर्धन, और प्रजनन और मछली के बच्चों का उत्पादन।

नियंत्रित स्थितियों के अन्तर्गत पूरे वर्ष घोंटे जल में पाले जाने वाले बड़े झींगों के बच्चों का बड़े पैमाने पर उत्पादन, बूड़ स्टॉक का विकास एवं हैचरी की व्यवस्था करना।

प्रग्रहण की स्थिति में टाइगर झींग में उत्प्रेरित परिपक्व तथा बूड़ स्टॉक के विकास के लिए तैयार किये गये प्रौद्योगिकी पैकेट तथा घर के पिछवाड़े सफेद झोंगा पालन की सरल व कम लागत वाली विधि।

व्यावसायिक स्तर पर आयात की जाने वाली झींगों की जातियों के हैचरी प्रौद्योगिकी तथा झींगों का बढ़ाने के लिए कल्चर का विकास। यह प्रौद्योगिकी कर्नाटक सरकार तथा केन्द्र शासित प्रदेश पांडिचेरी द्वारा शुरू की गई है।

छोटे जल की फिनयुक्त मछली जातियों के बूड़ स्टॉक का विकास, प्रजनन, बीज उत्पादन तथा प्रो-आउट कल्चर तैयार करना।

“फ्लो-थू” सुविधाओं से युक्त गोल्डन महशीर के लिए एक मानक हैचरी यूनिट स्थापित की गई है ताकि इसके जीव का विशाल पैमाने पर उत्पादन हो सके इसमें “एयरलिफ्ट” जल प्रणाली का प्रावधान है तथा वायु प्रवाह के लिए एक युक्ति भी लगायी गई है।

मोती पालन और मोती उत्पादन, खाने योग्य शुक्ति (आयसटर) कल्चर, समुद्री खरपतवार कल्चर, सीपी तथा क्लैम कल्चर के लिए प्रौद्योगिकियों का पैकेज तैयार किया गया है।

मेजर कार्य, एनओटिक कार्य, महशीर, हिल्सा तथा व्यावसायिक दृष्टि से महत्वपूर्ण अन्य फिनयुक्त मछलियों तथा खोलयुक्त मछलियों की जातियों को लम्बे समय तक हिम-शीत परिरक्षण की मानकीकृत तकनीकें मछली जीन बैंक में रखी जा रही हैं।

Implementation of Yashpal Committee Report

(b) whether any monitoring Committee was formed with respect to this report, and if so, what is the finding of the monitoring Committee; and

THE MINISTER OF STATE IN THE DEPTT. OF EDUCATION IN THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM SAKIA): (a) to (c) A Monitoring Committee for making periodical review of the progress of the implementation of the Yash Pal Committee recommendations had been set up in 1995. The Monitoring Committee developed monitoring proforma which were circulated to all the States. The States were also requested to identify nodal agencies to take the follow up action with regard to the recommendations of the Yash Pal Committee. Nodal officers/agencies have already been identified by 21 States/UTs. The implementation of the recommendations of the Yash Pal Committee is a Continuing process to be carried out by the State Governments which have agreed to and have initiated action on most of the recommendations.

Purchase of Skimmed Milk Powder by DMS

(c) whether Government propose to take some remedial measures to strengthen and improve these key programmes to achieve its goal of universalisation; and

(d) if so, the details thereof and if not the reasons therefor?

(c) and (d) The Programmes of Adult Education, Non-Formal Education and Operation Blackboard are programmes, operating across the country. As such, these are areas where slippages in the programmes have been observed. However, all these programmes are regularly monitored and reviewed at District, State and Central levels so that remedial measures are initiated.

Shifting of IGNOU Regional Office

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether the regional office of Indira Gandhi National Open University located at Chanakyapuri in New Delhi is proposed to be shifted to Tughlakabad area of New Delhi;

(b) if so, the reasons therefor;

(c) whether this office was centrally located and was quite convenient to people coming from different parts of Delhi;

(d) whether the proposed shifting will make the people to travel a long distance thus defeating the motto of Government save discl as much as you can;

(c) whether Government propose to cancel the shifting orders; and

(f) if so, the details thereof and if not, from private agencies is made by inviting quotations through open tenders, thereby ensuring competitive rates for the purchase.

(b) to (d) Do not arise, the reasons therefor?

THE MINISTER OF STATE IN THE DEPTT. OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) to (f) According to the information furnished by the Indira Gandhi National open University, the Delhi Regional Centre has to be shifted to Tughlakabad, as the Viswa Yuvak Kend-ra in Chanakyapuri the owner of the premises is unwilling to extend the lease agreement further. As the Regional Centre caters to 20 Study Centres, many of them being nearer Tughlakabad than Chanakyapuri, it cannot be said that such a shifting would be generally inconvenient. Further, the primary contact of the students is to be with their Study Centres, and hence location of the Regional Centre is not of primary concern to them.
